



**FORM ADV, PART 3 – CLIENT RELATIONSHIP SUMMARY
(FORM CRS)**
Effective June 1, 2020

MJB Asset Management LLC (“MJB,” “we” or the “Firm”) is registered with the Securities and Exchange Commission as an investment adviser. Brokerage and investment advisory services differ, and it is important for the retail investor to understand the differences. Free and simple tools are available for you to research firms and their financial professionals (“investment adviser representatives”) at Investor.gov/CRS, which also provides educational materials about broker-dealers, investment advisers, and investing.

What investment services and advice can you provide me?

MJB provides investment advisory services to individuals, businesses, not-for-profit organizations, high net worth individuals and institutional clients. The Firm was founded in 1997 by Richard Bregman, sole owner and Managing Member. We provide investment management services on both a discretionary and a non-discretionary basis to retail investors. A full description of our services can be found in the Firm’s disclosure brochure, which is prepared in accordance with SEC Form ADV, Part 2A (the “Brochure”). The Brochure is also available on the Firm’s website at www.mjbam.com/formcrs.

MJB’s minimum household size is \$1,000,000 of investable assets. The minimum may be waived at the Firm’s discretion. The Firm typically has discretionary authority for individual clients with regard to its investment management services. This means that we are granted authority to make trades in client accounts without obtaining the client’s consent prior to trading. There are no limitations on the types of investments that can be made on your behalf. The Firm’s investment management services include the selection of securities for client investment portfolios and the ongoing monitoring and management of client accounts. These services also include a formal review that is offered to clients no less frequently than annually. When an account is managed on a non-discretionary basis, we will gain the client’s consent prior to executing any trades.

The Firm also offers consulting services which may include one or more of the following activities: investment analysis and planning, insurance analysis, retirement planning, business and personal financial planning, and distribution strategy and analysis. The firm’s recommendations can also include specific recommendations regarding securities and other investments as well as insurance related products. Any referral for insurance products are referred to a third-party provider for which MJB does not receive compensation.

- *Given my financial situation, should I choose an investment advisory service? Why or why not?*
- *How will you choose investments to recommend to me?*
- *What is your relevant experience, including your licenses, education, and other qualifications? What do these qualifications mean?*

What fees will I pay?

Client accounts managed on a discretionary basis are charged an annual fee. The fee is calculated based on the fair market value of your assets under management on the last business day of each quarterly billing period. Fees are payable at the end of each calendar quarter for the previous billing period. Client accounts managed on a non-discretionary basis are charged a flat, annual fee. The minimum fee is \$10,000 per annum and is payable quarterly, in arrears, at the end of each calendar quarter. Fees paid to MJB are separate and distinct from the fees and expenses charged by mutual funds and exchange-traded funds to their shareholders.

You will pay fees and costs whether you make or lose money on your investments. Fees and costs reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are

paying. Fees and costs related to our investment advisory services are more particularly described in the Firm's Brochure under Item 5 – Fees and Compensation.

- *If I give you \$10,000 to invest, how much will go to fees and costs, and how much will be invested for me?*

What are your legal obligations to me when acting as my investment adviser? How else does your firm earn money and what conflicts of interest do you have?

When we act as your investment adviser, we have a fiduciary responsibility to act in your best interest and not put our interest ahead of yours. At the same time, the way we earn money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the advice we provide to you. The following conflicts exist:

Services Provided to Us by the Custodian of Your Assets. Certain services are provided to us by the custodian that we use to maintain custody of your account assets. The availability of these services benefits us because we do not have to produce or purchase them. The client asset threshold required to receive these services may give us an incentive to require you to maintain your account with this custodian. We believe, however, that our selection of this custodian is in the best interests of our clients.

Asset Based Fees. The more assets that are in your managed advisory account, the more you will pay in fees although the rate paid may decline. The Firm may therefore have an incentive to encourage you to increase the assets in your account. As a registered investment adviser, and as a fiduciary to our clients, MJB has a duty of loyalty and a duty to always act in utmost good faith, place our clients' interests first and foremost and to make full and fair disclosure of all material facts pertaining to potential or actual conflicts of interest. How do your financial professionals earn money?

As the sole owner, the Managing Member of the Firm participates in any profit or loss the firm may experience.

Do you or your financial professionals have a legal or disciplinary history?
